TERMS AND CONDITIONS

General information for the registered Architect/Architeturual Firms with the Cantonment Board, Shahjahanpur are requested to read the instructions carefully before filling the quotation form enclosed.

1. Architect/Architeturual Firms to furnish the details as per enclosed Quotation Form and quote rate percentage as per given instructions.

2. SCOPE OF WORK :

2.1 Preparing complete detailed project report (DPR) for constructions of shopping complex as mentioned in para 1 of quotation letter .

2.2 Preparing detailed estimate with respect to relevant MES/CPWD/State PWD specification, detailed BOQ, detailed project report and RCC drawings etc.all sufficient enough to invite tender.

2.3 The successful consultant/Architectural Firm will depute a technical staff for supervision during execution of civil construction work from issue of work order.

2.4 Consultant should anticipate all necessary allied work required to complete the work and make provision in the BOQ for execution.

2.5 Consultant should supply three sets of tender drawing and BOQ (Hard and Soft copies) to the Cantonment Board,Shahjahanpur at no extra cost.

2.6 Successful Consultant /Architectural Firms shall be responsible to obtain vetting of estimates alongwith design, drawings etc. prepared for the said project from MES/CPWD/NITs/IITs/Any Competent Govt. authority. However the fee towards vetting shall be paid-by Cantonment Board, Shahjahanpur.

3. The Cantonment Board/CEO reserves the rights to reject/approve the quoted rates without assigning any reason .

4. The decision of the CEO/Board shall be final on Architect/Architectural firm.

5. Consultant/Architechtrual Firms may inspect/survey the sites and conditions in details before submitting his quotation during working days of the office.

6. Any type of taxes existing/amended i.e. of State Govt. or Central Govt. will be paid by the Architect/Architectural Firm(Consultancy) as per prevalent rules of the Government.

PAYMENT SCHEDULE :

The payment to the Consultant /Architect Firm shall be made on the basis of actual payment (not to the basis of Estimate) made to the successful contractor approved by the Board and after obtaining necessary sanction from higher authority of the said work.
